- 5. Enrolment deposit/registration fee is normally non-refundable and non-transferable. Refund will only be considered on exceptional cases or as specified by the institutions. If refund is available, institutions have the right to request the applicants to provide supporting documents. For details, please contact individual institutions direct.
- 6. University Grants Committee-funded (UGC-funded) programmes for the 2023/24 academic year are provided by the following universities: City University of Hong Kong, Hong Kong Baptist University, Lingnan University, The Chinese University of Hong Kong, The Education University of Hong Kong, The Hong Kong University of Science and Technology and The University of Hong Kong. Programmes offered by Hong Kong Metropolitan University (HKMU), including those that can be applied through Joint University Programmes Admissions System (JUPAS), and The Hong Kong Academy for Performing Arts (HKAPA) are not UGC-funded programmes. For general reference, undergraduate programmes refer to full-time locally-accredited bachelor's degree programmes offered by institutions. For details, please contact individual institutions direct.
- 7. The Study Subsidy Scheme for Designated Professions/Sectors (SSSDP) has been introduced since the 2015/16 academic year to subsidise about 1 000 students per cohort to pursue designated full-time locally-accredited self-financing undergraduate programmes in selected disciplines. SSSDP has been regularised since the 2018/19 academic year with an increase in the number of subsidised undergraduate places to about 3 000 per cohort. Expansion of SSSDP and rationalisation of its implementation details will be announced at the dedicated webpage (www.cspe.edu.hk/sssdp) in due course. The subsidised undergraduate places under SSSDP are allocated mainly through JUPAS.
